# Deal finds right flavour

GROWING Brisbane-based specialist food and drink manufacturer Flavour Creations has a new head office and warehouse in Brisbane's south.

The company, started by Bernadette Eriksen in 1997, paid \$6.5 million for the two-level office/warehouse at 32 Murdoch Circuit, Acacia Ridge.

CBRE's Jack Pershouse and Peter Turnbull acted on behalf of the owner, Adelaide-based Angas Property Fund, while Raine & Horne Commercial's Paul Flego introduced Flavour Creations.

Mr Pershouse said the property was originally offered to the market for lease but struggled to attract any interest.

"The sales campaign drew a good level of interest with multiple inspections held with a range of owner-occupiers both locally and interstate." he said.

"In the end it was Flavour Creations who took out the sale.

"The campaign was part of our successful Going Going Gone portfolio strategy which groups together adverts from multiple clients, allowing them to run high impact adverts in premier positions."

The 15,845sq m site features a corporate style 5164sq m office/warehouse with hardstand and plenty of parking.

It was previously occupied by Officeworks.

Mr Flego said Flavour Creations had a requirement in the market for more than two years

"I showed them a lot of buildings. They wanted this building because it had extra land for further expansion," he said..

"It had a corporate office appeal from the street and more importantly you could not buy the land and construct a building like this for the price it was sold for."

Flavour Creations produces dysphagia and nutrition products supplies to hospitals, residential aged care facilities and directly to consumers.
